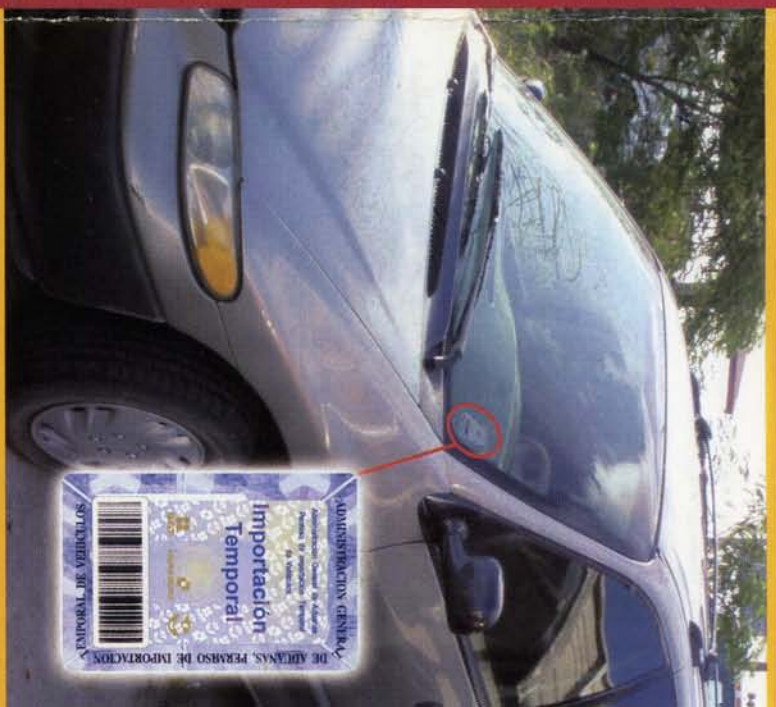

## Temporary importation of Vehicles



### ■ Who is eligible to import temporarily a vehicle?

- Foreigners with immigrant financiers' migratory status or non-immigrants, except refugees and political refugees
- Mexican nationals with legal residence abroad who can prove to be working, for more than one year, by means of official documentation

### ■ Where do I carry out the procedures?

- At the Mexican Consulates in Chicago, Dallas, Houston, San Francisco, Los Angeles, and soon in Sacramento, San Bernardino and Phoenix
- In any Citev sections operated by Banjercito, located in the north or south Mexican borders.
- In the Internet: [www.banjercito.com.mx](http://www.banjercito.com.mx), by means of a pre-registry and keeping the allocated registration number. Within the following 15 days you must present at any Banjercito module in the northern border of the country. (You will save time!

### ■ How much does it cost and how do pay?

- US\$27 plus VAT, with credit or debit international cards issued abroad and in the name of the importer
- If you don't have credit or debit cards, a deposit in cash of US\$200 to US\$400, depending on the year and model of the vehicle. The deposit will be returned at the time the vehicle is presented, before the expiration date in any of the Banjercito modules at the Mexican northern border

**Important:** The cost of the procedure in Mexican Consulates is US\$35.20 The payment should be made with credit or debit international cards in the name of the importer.

### ■ Who is allowed to drive the vehicle?

- **Mexicans:** the importer, his spouse, ascendants or descendants, or siblings, only if they have legal residence abroad; a foreigner with the appropriate migratory status, and any other person, if and when the importer travels on board of the vehicle
- **Foreigners:** the importer, his spouse, ascendants, descendants or siblings, if and when these are not from abroad and hold migratory status authorizing them to said effect or a national, if and when any of the authorized persons travels on board of the vehicle

### ■ What documents do I need?

- **Foreigners:** official identification and copies of the documents, both in force, issued by Mexican Migration Offices. Foreigners must provide evidence of their current migratory status issued at the Migration offices at the border
- **Mexicans:** a document proving legal residence abroad or an official document to prove the migratory status authorizing them to work abroad up to one year

In both cases:

- Document to prove the effective migratory status (Mexican legal resident: card of definitive or temporal resident, mica of work or naturalization certificate with double citizenship; tourist: passport, birth certificate, Affidavit, naturalization certificate or registration to vote)
- Title of property of the vehicle, registration, invoice or lease contract in the name of the importer
- Payment for the service to Banjercito
- Prove of the return of the imported vehicles in the past, if apply
